- **Due date** June 15, 2024. Provide this completed form to your municipal clerk on or before the due date. **Do not** submit this form to the Wisconsin Department of Revenue.

Failure to file – if you do not provide this completed form to your municipal clerk by June 15, 2024, they may not be able to timely file the Maintenance of Effort Report and be charged a penalty under state law.
