## INSTRUCTIONS

**NOTE: DO NOT COMPLETE THE STATEMENT OF TAXES UNLESS THE TAX ROLL HAS BEEN COMPLETED AND CHECKED FOR ACCURACY. THE STATEMENT OF TAXES MUST BE A SUMMARY OF THE COMPUTERIZED TAX ROLL PRODUCED BY THE COUNTY OR DATA PROCESSING CENTER.**

**SECTIONS A, B, E AND F** The State, County, School and Technical College apportioned tax levies have been preprinted for you. These levies were reported to us by the taxing jurisdictions. If the tax levies don't agree with your tax levy information you may change our number, but please attach a copy of the tax levy certification you received from the taxing jurisdiction.

**SECTION C** Special District Tax Levy. Please report any general property tax levies for your special district(s) in column 1a. Please report any state special charges in column 1b. Report total taxes and state special charges in column 2.

**SECTION D** Local Tax Levy. Complete all lines that apply to your taxation district. D-4 and D-5 will be preprinted if these types of charges were reported on your county apportionment sheet.

**D-1** Report other special purpose district tax levies. These are tax levies that are not apportioned over your entire taxation district (e.g. fire districts, street lighting districts, ambulance districts, utility districts, etc.). If more than one special purpose district levy is reported on D-1 show the detail of this line on the summary on page 3.

**D-2** Tax Increment. Unless you have a **County** Environmental Remediation TID (see D-3) report the total tax increment from all taxing jurisdictions. This will be line 6, column F from the Tax Increment Calculations Worksheet.

**D-3** County Environmental Remediation Tax Increment. Report the total tax increment for the County ER TID.

**D-6** All other town, village or city taxes. The amount levied on the tax roll for your taxation district, not including amounts reported on any other lines in Section D.

**D-7** Surplus Funds. Report an amount on this line only if line D-6 is zero (0).

**SECTION G** Total General Property Taxes Apportioned. Add the "total" lines of Sections A, B, C, D, E and F and report here.

**SECTION G-1 THROUGH G-5** Summary of Computerized Tax Roll. Copy these numbers from the computerized summary of your tax roll. In column 2 write in the total from G-1 column 3. Bring down the number from Section G. Subtract line G from G-1, this is your over or under run. Report this on G-5. If G-5 is negative, indicate by putting brackets around the number or use a minus sign in front of the number.

**SECTION H** Special Assessments and Charges. Section H on the front side of form is for totals only and showing break down of who will retain the money (column 3. "Other" is money collected for another taxing jurisdiction such as the state, county, special district or other taxation district). You must report the detail of Section H on page 3 Section H Detail Summary.

**SECTION J & K** Omitted Tax and 70.43 Corrections. Report omitted taxes, additional taxes due or refunds due from prior years' tax rolls. (Generally, these will not be on your computerized tax roll summary because a manual bill should have been created for each item.)

**SECTION M THROUGH O** DNR Forest Law Taxes and Occupational Taxes. Copy these numbers from your computerized tax roll summary (**Note:** Section O items may appear on a personal property summary or a special summary).

**SECTION T** Aggregate Amount of Taxes. Add Section G, G-5, H, J, K, M, N, and O and report total here.
