Instructions for DRY CLEANING FACILITY FEE RETURN

Dry cleaning facility fees are due in installments payable in amounts equal to 1.8% of the previous three month's taxable sales from dry cleaning apparel and household fabrics. Please complete this Dry Cleaning Facility Fee Return and send it to the address shown on front.

Line by Line Instructions

Line 1 - Enter your taxable sales from dry cleaning services performed at this location. Include pick-up, cleaning, processing, packaging, and delivery of the dry cleaning apparel or household fabric. Do not include sales taxes, dry cleaning fees or separately stated charges for tailoring, seamstress, laundry services or formal wear rentals.

Line 2 - Dry cleaning facility fee – multiply Line 1 by .018.

Line 3 - Interest and Penalty – include amounts for the following items, as appropriate on Line 3.

Late Filing Fee – If this return is not filed by the due date, enter a late filing fee

- Corporations – \$30.00
- Businesses other than corporations:
 - \$2 when the total fee (Line 2) is less than \$10
 - \$3 when the total fee (Line 2) is \$10 or more but less than \$20
 - \$5 when the total fee (Line 2) is \$20 or more

Exception: \$30 when this return is 60 or more days late.

Interest – The total fee (Line 2) that is due with a late-filed return is subject to interest at the rate of 1.5% per month until paid.

Negligence Penalty – If a late filing is due to negligence, the total fee (Line 2) is subject to a penalty of 5% for each month or fraction of a month the return is late, not to exceed 25%.

Line 4 - Total amount due (add lines 2 and 3).

Line 5 - Amount enclosed with this return. Enter the amount of payment included with this return.
