# Instructions for Completing LM-003 Municipal Light, Heat & Power Companies

## General Instructions:

One completed copy must be mailed to this Department on or before March 1. A 30-day extension for filing may be obtained, by going to <http://www.revenue.wi.gov/ust.index.html> and applying for an extension, provided the request is received before the due date. If you fail to file your report with us by the due date or extended due date, the Department of Revenue will add \$25 plus 5% of the total fees in accordance with Sections 76.28(6)(b) & (7) of the Wisconsin Statutes.

When using the fill-in form, you can enter the data directly into the annual report and the report will do the calculations. You will need to fill the entire report out before checking totals to confirm the correct answers.

Do not send any payment with your report. We will bill you on or about April 10.

Remember to report only revenues from operations located outside your municipality. Generally, these revenues will be the gross receipts from electric and gas customers located beyond your municipal borders. Include as other operating revenue rents from pole-contracts and rents received from other electric property located outside the municipality.

## Schedule B

**Line 1.** Revenues from forfeited discounts received from customers located outside the owning municipality should be reported here. If the utility does not keep separate records for forfeited discounts received from customers located outside the owning municipality, it can be estimated by using the ratio:

$$\frac{\text{The Number of Customers Outside of Owning Municipality}}{\text{Total Number of Customers minus the Number of Interdepartmental Customers}}$$

**Line 2.** Revenues from miscellaneous services provided for customers located outside the owning municipality should be reported here. If the utility does not keep separate records for miscellaneous service revenues received from customers located outside the owning municipality, it can be estimated on the basis of the ratio:
