In accordance with sec. 73.03 (52m), Wis. Stats., the Wisconsin Department of Revenue is authorized to refer debts to other states for the purpose of refund offset. A collection fee may be assessed to you if the other state intercepts a refund for a Wisconsin debt.

The Department of Revenue will cancel the referral of your delinquent tax debt if you do one of the following:

- **PAY YOUR DEBT IN FULL:** To pay your debt, use the attached voucher to send a check or money order made payable to the Wisconsin Department of Revenue for the total amount due. A payment agreement does not stop the Wisconsin Department of Revenue from submitting your unpaid debt to another state.
- **PROVIDE PROOF OF PAYMENT:** If you believe this debt has already been paid, you must send documentation to support your claim to the address or fax number shown below.
- **PROVIDE PROOF OF BANKRUPTCY:** If you have filed for bankruptcy and the automatic bankruptcy stay is in effect, you are not subject to offset during the course of the stay. Please send evidence of the bankruptcy to the address or fax number shown below.
