# Wisconsin Rate and Boundary Files Guide

## 1. Purpose

This guide's purpose is to aid programmers using the Wisconsin rate and boundary files from the department's website in determining the applicable Wisconsin state, county, and municipality sales and use taxes, Premier Resort Area Tax, or Local Exposition Taxes that may be due for a particular address.

## 2. Lookup Process

- a. To do a lookup you need either a street address and 5-digit zip code or a full 9-digit zip, and a sale date. Note: Only use the 9-digit zip if you don't get a match with the street address and 5-digit zip code. Some of the tables referenced below have begin and end effective dates (Columns B and C). Ignore rows where the sale date isn't between the begin and end effective dates.
- b. Using a street address and 5-digit zip code, search all rows with a Record Type A that matches by StreetPreDir, StreetName, StreetSuffix, StreetPostDr and Zip5. Look for the match that the street number falls within the range defined by AddrPrimLow and AddPrimHigh. If AddPrimOddEvenInd has a O, then the street number must be odd. If it's E, then the street number must be even, and if it's B, then it can be odd or even.

If no match is found searching a street address and 5-digit zip code, use a 9-digit zip. Look for all rows with a Record Type 4 where the Zip5 is in the range defined by Zip5Low and Zip5High and the Zip4 is in the range defined by Zip4Low and Zip4High. Once you have a match follow the instruction in c.

If the only information available is a 5-digit zip code, look for all rows with a Record Type Z where the Zip5 is in the range defined by Zip5Low and Zip5High. **Caution:** Most 5-digit zip codes include multiple counties or multiple municipalities. When a 5-digit zip code includes multiple counties or municipalities the row will not provide a FIPS County and/or FIPS Place, possibly resulting in the collection of an incorrect sales tax rate.

Below are examples for a lookup with a street address of "201 W Mifflin St and zip code 53703", and a "+4" 2511. See Part 4. below for additional examples.

c. After you determine the FIPSState, FIPSCounty and FIPSPlace from the matched rows above (e.g., 55, 025, and 48000 in Columns X to Z), and any applicable Special Tax District Codes (Columns AG through AR), use the rates table to find the values in JurisFIPS (Column C). Using the example from above, there are three applicable rows with rates shown in the Gen Tax Rate (Column D). Note: As seen in the Record Type Z results above, if using a 5-digit zip code, the municipality would not be known because the zip code is in multiple municipalities.

**d.** To determine the type of each tax, use the JurisType (Column B), or the JurisFips (Column C) for Special Tax District Codes, from the rates table to find the description in the table below.
