On July 27, 2019, your municipality will receive a First Dollar Credit payment from the Wisconsin Department of Revenue.

Payment Amount: \$504,060.20.

Your municipality must pay the full credit amount to your county treasurer on or before August 15, 2020. The county treasurer must then settle with each taxing jurisdiction on or before August 20, 2020.
