Amending Schedule H-EZ See "Amending Schedule H or H-EZ" on page 6 of the Schedule H instructions.

STEP 1: CLAIMANT INFORMATION

Print or type all information requested in the spaces provided. Include your social security number (and your spouse's, if applicable) and your tax district. Do not use an address label.

STEP 2: QUESTIONS

Complete lines 1 through 3. For more information on legal residency, see the instructions for line 2 of Schedule H.

STEP 3: HOUSEHOLD INCOME

Note: If your spouse died in 2014, see Part 5 on page 16 of the Schedule H instructions before you continue.

Line 4 – Income from Tax Return Fill in the income from your 2014 Wisconsin income tax return. For more information, including instructions for when you have already filed your return, see the instructions for line 7 of Schedule H.

Line 5 – Income - No Tax Return Fill in your total (and your spouse's total, if married) wages, interest, dividends, and other income taxable to Wisconsin on lines 5a and 5b. Attach a separate schedule if more space is needed.
